Attachment 1: Chair's Report to the 2018 Annual General Meeting

Chair's AGM report, SCA Ltd, Rowany Festival 2018

After 42 months as a Board member, 41 in Executive roles, it seems very strange to be retiring from this particular service to the SCA and leaving the Board which has taken up such a large part of my time and thoughts for the last three years and a half years. While demanding and challenging at times, I wouldn't have missed the experience and am glad that I made the choice to nominate way back in 2014.

Also retiring after three years of service each are David Beresford of Tasmania and Ray Gleeson of NSW. Ray and David joined the Board at the 2015 AGM and both have served one year as Deputy Chair. We also note our retiring Pegasus Editor Jen Fraser for her superb work on our official newsletter Pegasus. We thank them all for their contributions to the operations of the Board and wish them well in their next SCA adventures.

We leave the Board in the hands of continuing members Kate Turley (VIC), Tim Liersch (ACT), Simon Miller (ACT), Georgia Winter (NSW), Clem Avenell (WA) and from today Benjamin Smith (VIC). In addition, our Registrar Robyn Boyer and her deputy James Hodgkinson continue to tackle the demanding role of managing our memberships. As of today, we have vacancies for two more potential Board members to join us, from any state except ACT and VIC. Please speak with any Board member if you would like to know more about the opportunity, whether you are considering it for now or at some point in the future.

During the year, we have provided advice and information to members, reviewed policies and processes, investigated new software to streamline processes and improved our Board governance with formal Confidentiality Agreements and modernised Motion, Agenda and Minutes formats. One of our twelve scheduled monthly Board meeting was cancelled due to a spate of illness and unavoidable absences resulting in insufficient attendance.

We requested the previous Kingdom Seneschal to establish a subcommittee to conduct due diligence on the perennial question of 'should we purchase land'. This subcommittee has made considerable progress in examining the issues and their work will be continuing under a new leader after the recent retirement of Viscount Aylwin Greymane. We thank all those who have devoted their efforts towards investigating this complex matter.

The SCA Ltd website is undergoing a refresh to modernise it – expect to see differences as the year progresses. We have published our Corporate Mission Statement, essentially the Purpose in our Constitution, but rephrased to more accessibly say what we are about as an organisation. A statement on our values regarding diversity and inclusion has been created and published.

While there will always be more that could be done, when looking back we see progress made every year. For this I thank Board members past, present and future. I would also like to thank my family for supporting me during my term on the Board. It would have been much more difficult without their understanding.
