Chair's AGM report, SCA Ltd, Rowany Festival 2019

The end of my first year as Chair, and my second year on the Executive of the Board – has flown by!

Retiring after three years of service is Kate Turley of Victoria. Kate has been Secretary twice, and I honestly don't know how well the Board would have managed without her knowledge, humour, and service. Enjoy your well-earned rest and remember to say no occasionally. Tim Liersch (ACT) retired from three years' service in November 2018 and I would also like to thank him for his service in the role as corporate Treasurer for two years.

The Board continues with members Ben Smith (Vic), Simon Miller (ACT), Rob Aked (ACT), Cat Colwell (NSW), Clem Avenell (WA) (currently on a leave of absence) and from today Lara Mucha (Vic). As of today, we have vacancies for one more Board member to join us. During the year, we have provided advice and information to members, reviewed policies and processes, investigated new ideas to streamline processes and continued to improve our Board governance with Motion, Agenda and Minutes formats. Please see below my nomination for the role of Secretary within the Board of Directors for the SCA Ltd.

I hold the mundane role of Operations Manager & Members Services for the Australian Publishers Association. This has allowed me to see up close how the boards and committees of a professional association achieve their goals through good governance, as well as working to increase the range of membership services offered. This role includes paper writing for the Board, grant applications, database and content management, Xero based finance management, association administration, logistical support and the onboarding of new members. In my previous role as Wholesale Operations Manager, I rolled out a variety of new systems and workflows to improve process efficiency, as well as coordinating a launch of trade in the US, a fully integrated B2B e-commerce platform, and the conversion to a point-to-point tracked inventory system with automated replenishment reports.

I have participated consistently in the SCA for 13 years within the Barony of Rowany. During this time I have held a variety of college offices, and then offices of Seneschal & Chronicler for the Barony of Rowany.
