# **Application for SCA Ltd Weapons Exemption within Victoria**

All members of the SCA Ltd who live in, or plan to travel to, Victoria need to send a Statutory Declaration to the Registrar and receive a return email before they can acquire, carry or use a sword in Victoria. Note that this exemption does NOT extend to other prohibited weapons including rapiers, daggers, throwing blades, maces or flails.

#### **Instructions:**

**Please read this entire document.** Print pages 1-3, then complete the form on page 1 and the statutory declaration on pages 2 and 3. The statutory declaration must be witnessed by a person permitted to witness statutory declarations under the Victorian *Oaths and Affirmations Act 2018*. A full list of the people permitted can be found at <a href="https://justice.vic.gov.au/statdecs">https://justice.vic.gov.au/statdecs</a>.

Alternatively, you may send a copy of your firearms licence, private security licence or Victorian Chief Commissioner's permit under 8C of the Victorian *Control of Weapons Act 1990 (Weapons Collector Permit)* to the Registrar, along with the completed page 1 of this document.

- e) I will not acquire ownership of a weapon until 28 days after joining the SCA Ltd, unless I hold a firearms licence.
